The adjusted RSU award vests in one-third increments on December 31, 2014, 2015 and 2016. As reported herein, 24,345 shares of the Company common stock were withheld to satisfy Mr. Quinlan's tax withholding obligations on the shares vesting under the RSU award on December 31, 2016.
