1. On February 4, 2014, Mr. Rocha was awarded 12,171 Restricted Stock Units ("RSUs") representing rights to receive shares of common stock of SLM Corporation (the "Company") that were subsequently adjusted in the spin-off of Navient to reflect 34,139 RSUs outstanding and an additional 71 RSUs attributable to dividends. On February 4, 2017, 11,381 shares of such RSUs vested, of which 3,865 shares of the Company common stock were withheld to satisfy Mr. Rocha's tax withholding obligations.
