Explanation of Responses:

1. On January 28, 2019, the reporting person was granted restricted stock units ("RSUs") representing rights to receive shares of Common Stock of SLM Corporation (the "Company"), subject to vesting conditions, to vest in one-third increments on January 28, 2020, 2021, and 2022. On January 28, 2022, 6,375 shares vested in connection with these RSUs, of which 2,256 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.
2. Includes Dividend Equivalent Units issued in connection with RSUs held by the Reporting Person.
3. On January 28, 2019, the reporting person was granted RSUs representing rights to receive shares of Common Stock of the Company, subject to transfer restrictions that lapse in one-third increments on January 28, 2020, 2021 and 2022. On January 28, 2022, the transfer restrictions lapsed in connection with 2,821 of these RSUs, of which 785 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.
4. On January 30, 2020, the reporting person was granted RSUs representing rights to receive shares of Common Stock of the Company, subject to vesting conditions, to vest in one-third increments on January 30, 2021, 2022, and 2023. On January 30, 2022, 6,209 shares vested in connection with these RSUs, of which 1,845 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.
