- On April 20, 2020, the reporting person was granted restricted stock units ("RSUs") representing rights to receive shares of common stock of the Company, subject to vesting conditions, to vest in one-third increments on April 20, 2021, 2022 and 2023. On April 20, 2023, 83,878 shares vested in connection with these RSUs, of which 42,024 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.

- On April 20, 2020, the reporting person was granted RSUs representing rights to receive shares of common stock of the Company, subject to vesting conditions, to vest 40% on April 20, 2021, 40% on April 20, 2022 and 20% on April 20, 2023. On April 20, 2023, 165,136 shares vested in connection with these RSUs, of which 82,735 shares were withheld by the Company to satisfy the reporting person's tax withholding obligations.
